



As we enter another busy holiday shopping season, I want Floridians to be aware of common pitfalls consumers may face while rushing to purchase gifts for family and friends.

My 2022 Holiday Consumer Protection Guide is designed to help Floridians navigate the end-of-year shopping hustle and bustle, by providing the latest consumer protection tips and product safety information. It is important to stay on guard against online and in-person scams and be aware of recalled items while finishing holiday shopping lists.

The guide offers an array of information and useful tips for shoppers—including ways consumers can protect themselves when making online purchases and steps to take to avoid seasonal charity scams. It also includes a list of items recalled by the U.S. Consumer Products Safety Commission during the past year. During the holiday rush, Floridians are purchasing a lot of toys and household goods, so for shoppers' convenience, we have compiled a list of some of these recently recalled items that are particularly risky to children and teens.

By avoiding faulty and recalled items, and remaining vigilant against consumer fraud, we can build a Stronger, Safer Florida.

## **Holiday Season Shopping Tips**

---

*With so many consumer purchases taking place during the holiday season, it is a good time to be particularly mindful of potential scams, security issues and added costs that may impact your online purchases. Below are tips to keep your money safe while making the most of holiday shopping.*

- ❖ When shopping online, it is often wise to pay with a credit card instead of a debit card, if possible. Both payment methods allow you to dispute a charge if the merchandise never arrives or is different from what was ordered; however, with a debit card, the purchase is already deducted from your bank account and it may take days or weeks for your bank to reverse the charge.
- ❖ When ordering online, ensure that the web browser has a secure connection before inputting or submitting payment information. In the address bar, a padlock should appear to signify that your session is secure.
- ❖ Keep your receipts and be sure you understand retailers' return policies and periods so you can return any unwanted items for a full refund.
- ❖ Some retailers offer layaway plans or other payment options to allow shoppers to pay for items in installments or at a later date. Before agreeing to such a plan, be sure to ask whether the retailer charges a fee for its program and whether payments and any fees are refundable if the purchase is canceled or returned.
- ❖ When purchasing gift cards, check whether there is an additional activation fee, and provide the activation receipt to the recipient. Additionally, consider the retailer's financial situation before buying a gift card. If the retailer closes or declares bankruptcy, the recipient may not be able to enjoy the card's value.
- ❖ If shopping with a new retailer, check with the Better Business Bureau at [BBB.org](https://www.bbb.org) to determine whether other customers have filed complaints against them.

## Tips for Charitable Giving

---

*While the holiday season is a time for kind and generous deeds, scam artists may seek to take advantage of this spirit of giving. Below are tips to help ensure your charitable dollars do the most good this season.*

- ❖ Research before donating to a charity. Know if a charity is registered to solicit in Florida, be aware of how much your donation will actually go towards charitable programs as opposed to administrative expenses and check others' feedback on the charity. Websites like [FDACS.gov/ConsumerServices](https://www.fdacs.gov/ConsumerServices), [Guidestar.org](https://www.guidestar.org) and [CharityNavigator.org](https://www.charitynavigator.org) allow potential donors to review charities to help make sure the donation doesn't go to a scam organization.
- ❖ Do not give your credit card number or bank account information to someone who has called or emailed you unsolicited. If you are interested in donating to a charity that has contacted you, ask them to mail you information about the charity and a pledge form. Legitimate charities should have no problem with this request.
- ❖ Watch out for similar sounding charities. It is not unusual for sham charities to choose names that sound like the names of legitimate, well-known charities.
- ❖ Know the difference between tax exempt and tax deductible. An organization that is tax exempt does not have to pay taxes, but this does not necessarily mean that a contribution you have made to it is tax deductible. To check whether an organization is eligible to receive tax-deductible contributions, visit [Apps.IRS.gov/App/Eos/](https://apps.irs.gov/app/eos/).

## Product Recalls

---

*During this season of joy and giving, it is important to remain vigilant about the safety of the products brought into your home. What follows is a compilation of 2021-2022 U.S. product recalls in an easy-to-use guide that provides important information on items you may give or receive this holiday season.*

This guide reproduces U.S. Consumer Product Safety Commission information and details about recalled toys, baby items, sporting and recreational goods, furniture, and household products that are either designed for, or pose a particular risk to, children and teenagers. These items were among the more than 200 products recalled by the U.S. Consumer Product Safety Commission between October 1, 2021, and October 5, 2022. For more information regarding these products or for a comprehensive list of all product recalls, please visit [CPSC.gov](https://www.cpsc.gov).

Dangerous and defective products are the subject of recalls every year. When a product is recalled, the law requires manufacturers and retailers to remove the products from their shelves. However, products subject to recall sometimes slip by undetected and remain in stores; others may have been purchased before a recall was ever issued. Additionally, many products often continue to be offered for sale through online reseller websites well after a recall has been announced. Therefore, it is always important to do your research to make sure that the products you are buying or bringing into your home are safe and free of defect.

Taking a few minutes now to peruse this collection of recalled items will ensure a safer and more enjoyable holiday season for you and yours.



# Toys



## *Kidoozie Play Tents and Playhouses*

**Hazard:** The fabric playhouses and play tents fail to meet an industry flammability standard for these products, posing a risk of burn injuries to children.


**Remedy:** This recall involves Kidoozie Ice Castle Tent, King Size Medieval Castle, My Clubhouse, Pirate Den Playhouse, Pop up Theater Tents, Princess Hideaway Playhouse and Royal Castle Playhouse tents. Consumers should immediately take the recalled playhouses and play tents away from children, stop using them and contact Epoch Everlasting Play at 800-631-1272 for a full refund or free replacement product.



## *FAO Schwarz branded Toy Wood Play Smart Robot Buddy and Wood Sensory Boards*

**Hazard:** Due to a manufacturing issue, small parts from the products can come loose, posing a choking hazard to young children.

**Remedy:** This recall involves the FAO Schwarz Toy Wood Play Smart Robot and Toy Wood Sensory Board. Consumers should immediately take the recalled toys away from children, stop using them and contact MerchSource at 800-813-8762 to receive a pre-paid label to return the recalled toys and instructions on how to receive a full refund.



## *PlayMonster Kid O Hudson Glow Rattles*

**Hazard:** The rattle's legs can break off, posing a choking hazard to young children.


**Remedy:** Consumers should immediately take the recalled rattles away from children, stop using them, and contact PlayMonster at 800-469-7506 for instructions on receiving a \$25 refund. PlayMonster will provide consumers with a prepaid shipping label to return the recalled product.



### *Monti Kids Wooden Push Toys*

**Hazard:** The toy's rolling cylinder can separate, exposing the balls inside, posing a choking hazard to children.

**Remedy:** Consumers should immediately take the recalled toy away from children, dispose of the toy by throwing it into the trash, and contact Monti Kids at 800-674-3845 to receive a \$40 refund. Monti Kids is contacting all known purchasers directly.



### *Monti Toy Box with Bins*

**Hazard:** A small dowel can become exposed and detach from the toy box, posing a choking hazard to young children.

**Remedy:** Consumer should immediately stop using the recalled Box with Bins and contact Monti Kids at 800-674-3845 to receive a \$35 refund. Monti Kids is contacting all known purchasers directly.



### *Konges Sløjd Baby Mirror Activity Toy*

**Hazard:** The mirror can come out of the silicone bear cover if pushed, exposing sharp edges of the mirror, posing a laceration hazard to children.

**Remedy:** Consumers should immediately take the toy away from children, stop using the recalled toy and contact Konges Sløjd at 917-730-1075 for a full refund.



### *Primark Wooden Xylophone Toy*

**Hazard:** The xylophone's feet can loosen and fall off, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled xylophone and return it to a Primark store for a full refund.



## *Jungle Jumperoo Children's Toys*

**Hazard:** The toys' yellow poles contain levels of lead that exceed the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should immediately stop using the recalled toys and contact Jungle Jumperoo at 888-980-5867 for information on how to properly dispose of the yellow poles and to receive free replacement poles, including shipping. Jungle Jumperoo is contacting all known purchasers directly.



## *Manhattan Toy Company Activity Loops for Infants*

**Hazard:** Tubes on the Activity Loops toys can detach from the base releasing small plastic rings, posing a small parts choking hazard to children.

**Remedy:** Consumers should immediately stop using the Activity Loops toys, take the toys away from children and return them for a full refund either to the place of purchase or directly to Manhattan Toy. Manhattan Toy will supply a prepaid shipping label for returns directly to the company.



## *Asweets Wonder and Wise Activity Tables*

**Hazard:** Screws can become loose and/or detach from the xylophone component of the activity tables, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled activity tables, store them away in a place children cannot access until repaired, and contact Asweets at 833-422-2028 for a free repair kit, including shipping. The repair kit includes a replacement tabletop that includes a block sorting activity in place of the xylophone.



## *Asweets Wood Baby Activity Push Walker*

**Hazard:** Rubber rings on the rear wheels can separate from the wheels and detach from the Activity Walkers, posing a strangulation hazard to young children.

**Remedy:** This recall involves four-wheeled Wonder & Wise baby activity walkers. Consumers should immediately take the recalled walkers away from children, stop using them until repaired and contact Asweets at 833-422-2028 for instructions on getting free replacement rear wheels.



## *Boxine tonies Blocks*

**Hazard:** When two or more high-powered magnets are swallowed, either intentionally by younger children or accidentally by older children, the ingested magnets can attract to each other, or to another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.



**Remedy:** This recall involves tonies Blocks Marine Life, tonies Blocks Invention and Innovation, and tonies Blocks Gentle Giant Dinosaurs with magnets inside. Consumers should stop using the recalled blocks immediately, take them away from children, and contact tonies for instructions on returning the recalled blocks for a full refund. After the product has been received, tonies will provide the initial form of payment with a full refund and an additional \$14.99 [tonies.com](https://www.tonies.com) coupon code. The company is also contacting all purchasers directly. The recalled products are being remotely deactivated so that they no longer function.

## *DigitDots Magnetic Balls*

**Hazard:** When two or more high-powered magnets are swallowed, either intentionally by younger children or accidentally by older children, the ingested magnets can attract to each other, or to another metal object, and become lodged in the digestive system. This can result in perforations, twisting and/or blockage of the intestines, infection, blood poisoning and death.

**Remedy:** Consumers should stop using the recalled magnets immediately, take them away from children and contact HD Premier by email at [recall@ilovedigitdots.com](mailto:recall@ilovedigitdots.com) to receive a pre-paid label to return the recalled products. Upon receipt of the products, consumers will receive a refund.



## *B. toys Walk 'n' Learn Wooden Activity Toddler Walkers*

**Hazard:** The wheels and wheel attachment hardware can detach from the walker in small pieces, posing a choking hazard to young children.

**Remedy:** Consumers should immediately take the recalled toddler walkers away from young children and contact Battat at 844-963-2479 for a free repair kit with replacement wheels, attachment hardware and installation instructions. Known purchasers are being contacted directly.



## *Crate and Barrel Be the Band Music Sets*

**Hazard:** The maracas can break or become unscrewed and release the metal beads inside, posing choking and suffocation hazards to young children.

**Remedy:** Consumers should immediately stop using the recalled Be the Band Music Sets and contact Crate and Barrel for instructions on how to receive a refund in the form of a \$20 store credit for the maracas. Crate and Barrel is contacting all known purchasers directly.



## *Games Workshop Koyo Bounca The Squig Plush Toys*

**Hazard:** The pom-poms can detach from the toy, posing a choking hazard to young children.

**Remedy:** Consumers should immediately take the recalled plush toy away from young children and return the toy to any Games Workshop or Warhammer store for a full refund or email [custserv@gwplc.com](mailto:custserv@gwplc.com) for instructions on how to receive a full refund.



## *Colony Brands Children's Wood Wagons*

**Hazard:** Paint on the wood wagons, the plastic handles, and the red plastic cover contain levels of lead that exceed the maximums allowed. Excessive levels of lead can be toxic or cause other health problems to young children if the paint is ingested.

**Remedy:** Consumers should immediately take the recalled wagons away from children and contact Colony Brands at 800-991-4442 for instructions on how to receive a full refund. The involved retailers are contacting all known purchasers to arrange returns and providing pre-paid shipping labels and return instructions.



## *Backyard Play Systems Playsets with Wooden Roof*

**Hazard:** The wooden parts used to reinforce and create a decorative gable design on the wooden roof pose an entrapment hazard to children. Children can become trapped in the gap between the lower part of the roof structure and the bottom of the gable decoration.



**Remedy:** This recall involves home play equipment marketed under the brand names Yardline Play Systems (models Turbo Racer & Cloud Racer) and Gorilla Playsets (models Captain's Fort & Fort Highlander). The playsets include a solid wood roof with a lookout window, slides, swings, a rock-climbing wall and other play features.

Consumers should immediately stop using the recalled playsets and contact Backyard Play Systems at 866-890-2211 for a free repair kit which includes replacement wood parts, hardware and instructions. If a consumer is unable or does not want to do the repair themselves, Backyard will send a representative to perform the repair for them at no charge. Backyard Play Systems is contacting all known purchasers directly.

## *Scholastic Shake Look Touch Books*

**Hazard:** The pom poms on the book can detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately take the book away from young children and cut the pom poms off the book. Consumers can participate in the recall and receive a \$10 gift card by registering online at [www.recallrtr.com/slt](http://www.recallrtr.com/slt), submitting a picture of the book and removed pom poms, and affirming that the removed pom poms will be disposed of in the trash. Consumers can use the book after removing and disposing of the pom poms.



## *Blue's Clues Foot to Floor Ride-On-Toys*

**Hazard:** The ride-on toy can tip forward when a young child is riding it, posing fall and injury hazards to children.

**Remedy:** Consumers should immediately take the recalled ride-on toy away from children and stop using it. Contact the Huffy Corporation at 800-872-2453 for a free kit with instructions to install a new stop bar on the ride-on toy.



## *Big Game Hunters Mud Outdoor Kitchen*

**Hazard:** The brass water tap of the play kitchen contains levels of lead that exceed the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should immediately stop using the recalled Big Game Hunters Mud Kitchen, remove and dispose of the brass water tap, and contact DOM Enterprises & Mfg. Ltd. At 833-415-0078 for a free replacement water tap. Consumers who purchased online at [Amazon.com](http://Amazon.com) will be contacted through Amazon's messaging platform.



### *Future Motion Onewheel GT Electric Skateboards*

**Hazard:** The footpad can fail to disengage after the rider has dismounted while the board is in motion and the skateboard can unexpectedly continue to operate, posing an injury hazard to bystanders.

**Remedy:** Consumers should immediately stop using the skateboards with recalled footpads and contact Future Motion to determine whether their footpad is affected. Consumers with affected footpads will receive a free replacement skateboard footpad, including free shipping and installation instructions. Future Motion is contacting all known purchasers directly.



### *Halo Children's Projector Flashlights*

**Hazard:** A child can disassemble the projector flashlight and access the button cell batteries, posing ingestion and choking hazards.

**Remedy:** Consumers should immediately take the recalled projector flashlight away from children, stop using it, and contact Halo at 855-425-6266 for a full refund and a pre-paid shipping label to return the projector flashlight. Upon return, Halo will send the consumer a \$5 gift card redeemable at a major national retailer.



### *Pacific Cycle Schwinn Tone Electric Scooters*

**Hazard:** The e-scooter's handlebar grips can loosen or crack, posing fall and injury hazards.

**Remedy:** This recall involves the Tone 1, Tone 2 and Tone 3 models of the Schwinn Electric Scooter. Consumers should immediately stop using the recalled e-scooters and contact Pacific Cycle at 877-564-2261 for a free repair kit. Consumers will need to provide the serial number of their scooter and a mailing address.



## *Epoch Everlasting Kidoozie Activity Desk Toys*

**Hazard:** When attached to a crib, a protruding knob on the activity desks can become entangled with clothing on a child, posing an entanglement hazard. The opening in the handle on the desks can also pose a jaw entrapment hazard to children under 18 months.



**Remedy:** Consumers should immediately take the toys away from children, stop using them and contact Epoch Everlasting Play at 800-631-1272 for a free replacement or a full refund. The company will provide consumers with a pre-paid shipping label to return the recalled activity desk.

## *Hearing Lab Technology/Lucid Audio Children's HearMuffs*

**Hazard:** The AAA alkaline batteries included in the recalled HearMuffs can rupture, posing hearing, projectile and/or burn injury.

**Remedy:** Consumers should immediately stop using the recalled HearMuffs and contact Hearing Lab Technology/Lucid Audio at 833-408-0479 to receive two new replacement AAA batteries free of charge.



## *Lovevery Drinking Cup with Handle in The Inspector Play Kits*

**Hazard:** The handle can detach from the steel cup, posing a choking hazard to young children.



**Remedy:** Consumers should immediately take the recalled drinking cups away from children, stop using them, and contact Lovevery at 877-367-3175 for a free replacement cup. Lovevery is contacting all known purchasers directly.



# Baby & Toddler Goods



## *Kids Tales Sleepwear*

**Hazard:** The children’s pajamas fail to meet the flammability standards for children’s sleepwear, posing a risk of burn injuries to children.

**Remedy:** Consumers should immediately take the recalled sleepwear away from children and contact Kids Tales by email at [fzskmy.yxgs@outlook.com](mailto:fzskmy.yxgs@outlook.com) for a full refund. Consumers who purchased the pajamas will be asked to destroy the garments by cutting them in half and sending a photo of the destroyed garment. Upon receipt of the photo, consumers will be issued a full refund of the purchase price.



## *The Children’s Place Baby Boy Rompers*

**Hazard:** The metal snaps on the rompers can detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately take the recalled rompers away from children and return the rompers to any The Children’s Place store for a full refund. The company will send an email notice to all customers who bought the product on The Children’s Place website with instructions on how to receive a full refund for the recalled products.



## *Loulou Lollipop Children’s Sleepwear*

**Hazard:** The children’s pajamas fail to meet the tight-fitting flammability standards for children’s sleepwear, posing a risk of burn injuries to children.

**Remedy:** Consumers should immediately take the recalled sleepwear away from children and contact Loulou Lollipop at 833-456-8568 for a full refund. Consumers who purchased the sleepwear will be asked to destroy the garments by cutting them in half and sending the company a photo of the destroyed product, including the neck label. Upon receipt of the photos, consumers will be issued a full refund or a store gift card. Loulou Lollipop is contacting all known purchasers directly.



## *Winter Water Factory Infant French Terry Jumpsuits, Rompers, Snap Suits, Baby Dresses and Bibs*

**Hazard:** The snaps on the recalled garments can detach and expose small sharp prongs, posing choking and laceration hazards to young children.

**Remedy:** This recall involves all infant French terry jumpsuits, rompers, snap suits, baby dresses and bibs identified by one of the following codes at the bottom of the label in the back of the neck: TX-JM-I-XXII, TX-JM-VII-XXI, TX-JM-I-XXI, TX-JM-VII-XX. Consumers should immediately stop using the recalled items and contact Winter Water Factory by email at [safety@winterwaterfactory.com](mailto:safety@winterwaterfactory.com) for instructions on how to receive a full refund or a refund in the form of a store credit.



## *The Red League Children's Pajamas*

**Hazard:** The children's pajamas fail to meet the federal flammability standards for children's sleepwear, posing a risk of burn injuries to children.

**Remedy:** Consumers should immediately take the recalled pajamas away from children and contact The Red League at 888-754-4030 to receive a pre-paid mailer and instructions on how to return the garment(s) for a full refund. The Red League is also contacting consumers who purchased the pajamas directly to provide them a prepaid mailer to return the garment for a full refund.



## *Hanna Andersson Baby Long Sleeve Wiggle Sets*

**Hazard:** The snaps on the long sleeve top can detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled Baby Long Sleeve Wiggle Set and contact Hanna Andersson Customer Care at 800-222-0544. Hanna Andersson will be providing postage-paid labeling to consumers for the return of the product for a full refund. Hanna Andersson is contacting all known purchasers directly.



## *Hanna Andersson Baby Ruffle Rompers*

**Hazard:** The snaps on the romper can detach, posing a choking hazard to young children.

**Remedy:** Consumers should immediately stop using the recalled Ruffle Romper and contact Hanna Andersson Customer Care at 800-222-0544. Hanna Andersson will be providing postage-paid labeling to consumers for the return of the product for a full refund. Hanna Andersson is contacting all known purchasers directly.



## *Stokke Klikk High Chairs*

**Hazard:** The white plastic seat can break, posing fall and injury hazards to children.

**Remedy:** Consumers should immediately stop using the recalled white highchairs and contact Stokke at 877-978-6553 for a free replacement. Consumers will receive the free replacement Klikk highchair in white after visiting Stokke's website to confirm their product is included in the recall and registering the product online.



## *Zeno Infant Walkers*

**Hazard:** The infant walkers fail to meet the federal safety standard. They can fit through a standard doorway and are not designed to stop at the edge of a step as required by the federal safety standard. The walkers also have leg openings that allow the child to slip down until the child's head can become entrapped at the neck. Babies using these walkers can be seriously injured or killed.

**Remedy:** Consumers should immediately stop using the recalled infant walkers and contact Zeno via e-mail at [cs@zeno999.com](mailto:cs@zeno999.com) to receive a shipping label to return the infant walker free of charge. Upon receipt of the infant walker, consumers will be issued a full refund of the purchase price. Zeno is notifying all known purchasers directly.



### *Karmas Far Infant Bath Seats*

**Hazard:** The bath seats fail to meet the federal safety standard for infant bath seats, including requirements for stability and leg openings, and can tip over while in use, posing a drowning hazard to babies.

**Remedy:** Consumers should immediately stop using the recalled infant bath seats and contact Karmas Far at 909-372-6955 to receive a pre-paid label to return the products. Upon receipt of the products, consumers will be issued a full refund for the purchase price. Karmas Far is notifying all known purchasers directly.



### *First Choice Glass Baby Bottles*

**Hazard:** The markings on the outside of the bottles contain levels of lead that exceeds the federal lead content ban. Lead is toxic if ingested by young children and can cause adverse health issues.

**Remedy:** Consumers should immediately stop using the recalled glass baby bottles. Contact NUK for information on how to return the recalled baby bottle and receive a full refund. Consumers can register for a kit to return the baby bottles for free at [www.recall.nuk-usa.com](http://www.recall.nuk-usa.com). Some Amazon sellers are contacting all known purchasers directly.



### *4moms MamaRoo and RockaRoo Infant Swings and Rockers*

**Hazard:** When the swing or rocker is not in use, the restraint straps can dangle below the seat and non-occupant crawling infants can become entangled in the straps, posing a strangulation hazard.

**Remedy:** Consumers with crawling should immediately stop using the recalled swings and rockers, place them in an area where crawling infants cannot access and contact 4moms at 877-870-7390 immediately to register for a free strap fastener that will prevent the straps from extending under the swing when not in use.



## *BIBS Baby Bottles*

## *Cervelo USA R5 and Caledonia-5 Bicycles and Cervelo Replacement Stems*

**Hazard:** The handlebars on the bicycles can slip in the stem and cause the rider to lose control, posing a fall hazard.

**Remedy:** Consumers should immediately stop using the two recalled models of Cervélo bicycles and Cervélo replacement stems and contact their authorized Cervélo dealer to arrange for a free repair to replace the faceplate.



## *Spalding Momentous EZ Portable Basketball Goals*

**Hazard:** Welds in the arm attaching the backboard to the pole can fail and cause the backboard to fall, posing an impact injury hazard to consumers.

**Remedy:** Consumers should immediately stop using the portable basketball goals and contact Spalding at 800-558-5234 to arrange for a technician to remove the original arm and install a new arm on the goal system. Spalding is contacting all known purchasers.





# Household Goods



### *Best Buy Insignia Air Fryers and Air Fryer Ovens*

**Hazard:** The air fryers and air fryer ovens can overheat, posing fire and burn hazards.

**Remedy:** Consumers should immediately stop using the recalled air fryers and air fryer ovens and register online at [www.insigniaairfryerrecall.expertinquiry.com](http://www.insigniaairfryerrecall.expertinquiry.com) or call Best Buy at 800-566-7498 to arrange a return through a pre-paid shipping box and label and return instructions. Best Buy is also contacting all known purchasers directly to arrange returns. The consumer should not return the recalled air fryers and air fryer ovens to a Best Buy retail store for a refund. The consumer will receive a refund in the form of a credit for use at Best Buy stores or [BestBuy.com](http://BestBuy.com).



### *IKEA METALLISK Espresso Makers*

**Hazard:** The recalled espresso makers with the stainless-steel safety valve can burst and expel hot contents, posing burn or other injury hazards to consumers.

**Remedy:** Consumers should immediately stop using the recalled espresso makers. Units bearing date stamps 2040 through 2204 can be returned for a full refund to any Ikea store location or by mail using a pre-paid label. Proof of purchase (receipt) is not required.



### *Accompany USA Ceramic Mugs with Cork Bottoms*

**Hazard:** The coffee cup can crack or break when hot liquid is poured into it, posing a burn hazard.

**Remedy:** Consumers should immediately stop using the recalled ceramic mugs and contact Accompany USA at 909-595-0178 to receive a full refund.



### *Norwex USA Ceramic Knives*

**Hazard:** The handle on the Norwex ceramic knives can break during use, posing a laceration hazard.



**Remedy:** This recall involves Norwex Ceramic Knives with a ceramic blade and bamboo handle. Norwex is printed on the handle. Consumers should immediately stop using the recalled ceramic knives and contact Norwex USA at 833-882-5569 for information on how to obtain a free replacement and to request a return kit which includes a pre-paid return shipping label.

### *ALDI Bee Happy 12 Days of Craft Advent Calendars*

**Hazard:** Surface paint on the brown bell found in “Day 10” of the advent calendar contains levels of lead that exceed the federal lead paint ban, posing a risk of lead poisoning. Excessive levels of lead can be toxic or cause other health problems to young children if the paint is ingested.



**Remedy:** Consumers should immediately take the recalled advent calendars away from children and contact ALDI at 833-460-2092 for a full refund.

### *Husqvarna All-Wheel Drive Robotic Lawnmowers*

**Hazard:** The lithium-ion battery in the lawnmower can overheat, posing a risk of fire.



**Remedy:** Consumers should immediately stop using the recalled lawnmowers and download the free software update that Husqvarna Professional Products is pushing to the recalled units. Consumers with units having more than 1,200 charging cycles will also receive a free replacement battery. Husqvarna Professional Products is contacting all known purchasers directly.

## Target Decorative Mailbox

**Hazard:** The mail slot on the mailbox can be sharp, posing a laceration hazard.

**Remedy:** Consumers should immediately stop using the recalled mailbox and return it to any Target Store for a full refund in the form of a Target gift card. Consumers can also contact Target to receive a prepaid return label to return the mailbox for a full refund in the form of a Target gift card.



## Fitbit Ionic Smartwatches

**Hazard:** The lithium-ion battery in the Ionic smartwatch can overheat, posing a burn hazard.

**Remedy:** This recall involves the Fitbit Ionic Smartwatch with model numbers FB503CPBU, FB503GYBK, FB503WTGY, FB503WTNV. Consumers should immediately stop using the recalled Ionic smartwatches and contact Fitbit at 888-925-1764 to receive pre-paid packaging to return the device. Upon receipt of the device, consumers will be issued a refund of \$299. Fitbit will also provide participating consumers with a discount code for 40% off select Fitbit devices.



## BrushX Hot Air Brushes

**Hazard:** The recalled brushes do not have an immersion protection device, posing an electrocution or shock hazard to the user if it falls into water when plugged in.

**Remedy:** Consumers should immediately stop using the recalled hot air brushes, destroy them by unplugging the unit and then cutting the cord, and email a photo of the destroyed product to BrushX at [replacement@mybrushx.com](mailto:replacement@mybrushx.com) to receive a free, upgraded replacement product. BrushX is contacting all purchasers directly.


